

The Shop Next Door Artisan Contract

This Artisan Contract ("Artisan Contract") is made and entered into as of the date last written below, by and between Brewed Awakenings, Inc. d/b/a The Shop Next Door by Brewed ("Next Door"), and _____ ("Artisan").

RECITALS

- A. Artisan produces handmade artwork, crafts, and/or related items, and desires to arrange for the sale of certain items by Next Door ("Artwork").
- B. Next Door desires to store, market, and sell the Artwork according to the terms set forth in this Artisan Contract.

Now, therefore, for good and valuable consideration, Next Door and Artisan agree as follows:

TERMS

- 1. Policies and Procedures.** The policies and procedures governing how Next Door will store, market, and sell the Artwork are set forth in a document entitled The Keys to the Shop Next Door: Our Policies and Procedures ("Policies"). A copy of the Policies is attached to and made a part of this Artisan Contract. Artisan acknowledges that he or she has reviewed and understands the Policies.
- 2. Payment terms.** Next Door will pay Artisan pursuant to the Policies. At the end of each month your sales will be compiled and payment ready for you on the 5th of the following month. (Example: June sales ready July 5th) Artisan may choose one of the following methods :
 - ___ Payment by check sent via U.S. Mail (Artisan is responsible for providing self-addressed stamped envelopes)
 - ___ Payment by check picked up by Artisan at Next Door (proper identification required)
- 3. Liability; Ownership.** Next Door assumes no liability for Artwork subject to this Artisan Contract. Artisan is responsible for maintaining any desired insurance coverage for the Artwork. Subject to the terms of this Artisan Contract, Artisan retains ownership of the Artwork and, if a piece sells, title to the Artwork will pass directly from Artisan to the buyer.
- 4. Inventory Form.** As provided in the Policies, Artisan must record the Artwork on the inventory form provided by Next Door. If Next Door authorizes Artisan to sell additional artwork, Artisan must provide Next Door with an updated Inventory Form. The Inventory Form(s) shall become part of this Artisan Contract. Please list each item on a separate line and include an item number. (Example: Jill Brown may have JB1, JB2, and so on for item numbers.)

5. **Length of Contract** The items will sell at the agreed upon retail price on the inventory sheet until Next Door deems it necessary for the item to go on sales move the product. Next Door will contact the Artisan to decide on a sale price or take the items back. If Next Door contacts you to pick up your items you must pick them up within 30 days. After 30 days Next Door will consider the items abandoned and donate them to charity.

6. **Original Nature of Artwork.** Artisan represents and warrants that the Artwork is the Artisan's own original work, and that the Artwork does not infringe or violate the rights of any party, or defame any party. Artisan further represents and warrants that Artisan is authorized to enter into this Artisan Contract. Artisan agrees to indemnify and hold Next Door harmless from and against any and all losses, liabilities, damages, and/or expenses Next Door suffers or incurs arising out of any breach or alleged breach of the representations and warranties set forth in this paragraph.

7. **Artisan Contact Information.** Artisan provides accurate contact information to Next Door. Artisan agrees to keep it up to date as necessary as it is our only way to contact you.
